## GENERAL USE GUIDE

This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations a compatibility test is recommended.

<b>Golf Course Greens</b>	Apply 3.0 to 12.0 fl oz per 1,000 sq ft in enough water to provide sufficient foliar coverage. Repeat application every 7 to 14 days. Transition and warm season turf may require more frequent applications.
<b>Golf Course Tees and Fairways</b>	Apply at 3.0 to 6.0 fl oz per 1,000 sq ft in 0.5 to 2.0 gal per 1,000 sq ft of spray solution. Repeat application every 2 to 3 weeks.
<b>Lawns Athletic Fields</b>	Apply at 1 to 2 gal per acre in 25 to 88 gal per acre of spray solution. Use the lower rates if daytime temperatures exceed 85 degrees or if turf is exhibiting symptoms of drought stress.

**In Virginia, this lawn fertilizer, which contains phosphorous, is intended only for nonagricultural use on (i) turf during its first growing season, (ii) turf areas being repaired or renovated, and (iii) turf where a soil test performed within the last 3 years indicates a phosphorous deficiency. This fertilizer is not intended for the routine maintenance of turf.**
