Golf Course Greens	<p>Apply 1.5 to 4.0 fl oz per 1,000 sq ft in enough water to provide sufficient foliar coverage.</p> <p>Repeat application every 7 to 14 days.</p> <p>May be combined with liquid fertilizers, other bio-stimulants, and surfactants</p>
Fairways, Tees And Athletic Turf	<p>Apply 1/2 to 1 gal per acre in enough water to provide sufficient foliar coverage. Repeat every 2 to 4 weeks.</p> <p>Recovery and Grow-In: Apply 1.5 to 3 fl oz per 1,000 sq ft every 7 days or 3.0 to 6.0 fl oz per 1,000 sq ft every 14 days.</p>
Shrubs and Ornamentals	<p>Drench with 1.0 to 2.0 fl oz per gal of water at transplant or throughout the growing season.</p> <p>Repeat drench every 14 to 28 days.</p> <p>Foliar applications can be made with 1.0 to 2.0 fl oz per gal of water every 14 to 28 days.</p>
