However, due to variability in water sources and pesticide formulations a compatibility test is recommended. **Golf Course** Apply 1.0 to 2.0 fl oz per 1,000 sq ft. **Greens and Tees** Repeat application every 10 to 14 days or as needed. **Golf Course** Apply 1.0 to 3.0 fl oz per 1,000 sq ft in sufficient water for proper coverage. **Fairways** Repeat application every 10 to 14 days depending on **Sports Turf** conditions and desired effects. Establish an application schedule that allows treatments to immediately follow heavy traffic events for quicker **Aeration Recovery** Apply 2.0 to 3.0 fl oz per 1,000 sq ft. and Grow In Water into root zone after application.
