### For Use on Warm-Season Turf

This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations a compatibility test is recommended.

<b>Golf Course Greens and Tees</b>	Apply 1.0 to 2.0 fl oz per 1,000 sq ft. Repeat application every 10 to 14 days or as needed.
<b>Golf Course Fairways Sports Turf</b>	Apply 1.0 to 3.0 fl oz per 1,000 sq ft in sufficient water for proper coverage. Repeat application every 10 to 14 days depending on conditions and desired effects. Establish an application schedule that allows treatments to immediately follow heavy traffic events for quicker recovery.
<b>Aeration Recovery and Grow In</b>	Apply 2.0 to 3.0 fl oz per 1,000 sq ft. Water into root zone after application.
