This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations, a compatibility test is recommended. For foliar applications delay irrigation or mowing for 12 to 24 hours.

Golf Course Turf Lawn Care Athletic Fields

Apply 1.0 to 3.0 fl oz per 1,000 sq ft in enough water to provide sufficient foliar coverage. Repeat application every 7 to 21 days. During rapid turf growth, higher application rates may be required to maintain the desired turf colour.

Shrubs Trees Ornamentals

Deep Root Injection: Apply 2 fl oz per inch of trunk diameter.

Foliar Spray: Apply 15 fl oz in 100 gal water.

Soil Applications: Mix 0.5 fl oz per gal water. Apply 2 gal of this solution per square yard of garden.

Transplants: Apply 1.5 fl oz per gal water. Apply 1 gal of this solution per inch of trunk diameter.
