Foliar-Pak Base Magnesium is soil-applied product designed to fill the void between foliar magnesium applications, and soil-applied granular applications. Providing more magnesium than a foliar application, while being much smaller in particle size compared to a granular application, allows Foliar-Pak Base Magnesium to begin working in the soil during in-season applications. This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations a compatibility test is recommended. Shake well.

**Maintenance Rate
(Greens, Tees,
Fairways, Sports Turf)**

Apply 1.5 oz per 1,000 sq ft in enough water to sufficiently water into the soil profile. Reapply weekly or biweekly during the growing season as needed.

**Amendment Rate
(Greens, Tees,
Fairways, Sports Turf)**

Apply 6-9 oz per 1,000 sq ft in enough water to sufficiently water into the soil profile. Reapply as needed per soil tests.
