5. FIREFIGHTING MEASURES

Suitable Extinguishing media: Water spray, foam, CO₂, or dry chemicals may be used in areas where this product is stored.

Specific Hazards: None.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Precautions to be Taken in Handling: Keep container sealed when not in use. Safety goggles and eyewash recommended. USDA-accepted nitrile (CFR-20) or neoprene rubber (CFR-21) recommended. Wear appropriate clothing to prevent repeated or prolonged skin contact.

Precautions to be Taken in Storage: Product should be stored in a dry place. Reseal containers between uses for maximum storage stability.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

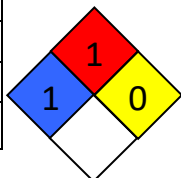
