Use to maintain turfgrass throughout the growing season. This product is tank-mix compatible with most fertilizers, pesticides, and PGRs. However, due to variability in water sources and pesticide formulations, a compatibility test is recommended.

Golf Course Tees, Fairways, and Sports Turf

Apply 1.5 to 3.0 fl oz per 1,000 sq ft in enough water to provide sufficient foliar coverage.

Repeat applications every 14 to 30 days or as needed.

Do not store in temperatures below 40°F.
